壹、申請資格 Application Qualification

- 一、外國學生須符合教育部所採認之高中、專科、大學或獨立學院畢業者。具高中(職)畢業資格者，得申請入學本校四年制學士學位班；具大學畢業資格者，得申請入學本校碩士學位班。
 1. International students should graduate from a senior high school, vocational school, university, or independent college verified by the MOE. Those who have graduated from senior high schools can apply for the four-year bachelor's degree program while those who have graduated from universities can apply for the master's degree program.
- 二、本招生簡章所稱外國學生，指具外國國籍且未曾具有中華民國國籍。具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者(計算至 2024 年 8 月 1 日止且每年在台停留時間不超過 120 日)，亦得依規定申請入學：
 - (一) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。
 - (二) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。
 - (三) 前二款均未曾以僑生身分在臺就學，且未於申請入學當學年度經海外聯合招生委員會分發。

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。

第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

- (一) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
- (二) 就讀本部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
- (三) 交換學生，其交換期間合計未滿二年。
- (四) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

具外國國籍並兼具中華民國國籍，且於外國學生來臺就學辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

2. An applicant shall be considered an international student if, at the time of application, he/she is a foreign national, has never held a Republic of China (ROC) passport, and does not possess overseas Chinese student status. An applicant of foreign nationality who, pursuant to the following requirements, has continuously resided overseas for no less than six years (up to August 1, 2024) is also qualified to apply for admission under this regulation.
 - (1) Applicants holding both foreign and R.O.C. nationalities but have never established any household registration in Taiwan.
 - (2) Applicants holding foreign nationality who once held R.O.C. nationality must have abdicated their R.O.C. nationality for more than 8 years before application. (As determined by the Ministry of Interior up to August 1, 2024)
 - (3) Applicants in the preceding subparagraph 1 and subparagraph 2 should have never held overseas Chinese student status, also can not apply to the "University Entrance Committee for Overseas Chinese Students" for admission in the enrollment year

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has

never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.

The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The term “overseas” used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

- (1) Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;
- (2) spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
- (3) spent a total period of less than two years in Taiwan as an exchange student; or
- (4) spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority;

A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to these Regulations may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

三、若申請者符合以下任一條件，則**不適用**外國學生申請入學：

- (一)申請者曾以僑生身分在中華民國申請或就讀。
- (二)申請者曾在中華民國以外國學生身分申請並完成高中學校學程，欲繼續在中華民國就讀大學。
- (三)申請者曾被學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者。
- (四)申請者具有香港或澳門或中華人民共和國國籍。
- (五)申請者具有中華民國國籍(根據國籍法第二條之解釋)。
- (六)申請者曾具有中華民國國籍，且至本校開學日止，尚未經內政部許可放棄達八年以上(所定八年之計算，以內政部許可喪失國籍之日起算至就讀本校開學日期為準)。

註：【國籍法第二條】規定：

有下列各款情形之一者，屬中華民國國籍：

- 1.出生時父或母為中華民國國民。
- 2.出生於父或母死亡後，其父或母死亡時為中華民國國民。
- 3.出生於中華民國領域內，父母均無可考，或均無國籍者。
- 4.歸化者。

前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。如違反以上任一條件，經查證屬實者，撤銷其入學資格、開除學籍或撤銷其本校畢業資格，且不發給任何學歷證明。

3. Applicants who fit into any one of the following conditions do not qualify and may **not** apply as international students.

- (1) Who have applied or studied in Taiwan as an overseas Chinese status.

- (2) Who have applied and completed high school curriculum as international students in Taiwan.
- (3) Who have been dropped by a Taiwanese university.
- (4) Who are citizens of Hong Kong, Macau, or People's Republic of China nationals °
- (5) Who are ROC nationals (according to the explanation of Article 2 of the Nationality Act)
- (6) Who have the nationality of the Republic of China once and whose ROC nationality has not been revoked by the ROC Ministry of Interior within the past 8 years (the calculation of eight years starts from the date of denationalized, approved by the MOI to the date that the semester starts)

Notes:

According to Article 2 of the Nationality Act of the Republic of China, a person who meets any one of the following requirements has been considered the nationality of the Republic of China

1. One of the applicant's parents was a national of the Republic of China when he/she was born.
2. The applicant was born after the death of his/her father or mother, and his/her father or mother was a national of the Republic of China at the time of death.
3. The applicant was born in the territory of the Republic of China, whose parents can't be ascertained or both were stateless persons.
4. The applicant has undergone the nationalization process.

Subparagraph 1 and subparagraph 2 above shall also apply to the persons who were minors at the time of the revision and promulgation of this Act.

If any subparagraph above is violated and has been verified to be true, the applicator's qualification is cancelled, student status is expelled, or graduation qualification is cancelled and no educational certification will be issued.

肆、甄審方式 Review and evaluation process

一、甄審項目：書面審查（100%）。

1. Review Items: Written review（100%）

二、審查內容：

以書面資料審查為主，包含：入學申請表(含2吋半身彩色證件照)、入學申請切結書、財力證明、入學文件審查授權書、在臺就學檢核表及切結書、在校成績、推薦信、留學計畫、語文能力證明、護照影本或國籍證明文件、最高學歷或同等學力證明文件。如有其他有助審查之資料將酌予加分。

※大學部課程主要以中文授課，申請人至少應具備華語文能力，且足以正式修讀大學所有課程。申請人之語文基礎能力由各系（所）於初審時認定之，必要時得通知申請人接受華語文能力測驗。

※如報名人數未達招生名額，本校得依審查結果決定是否錄取。

2. Review Contents: Written documentations are mainly reviewed such as school transcripts, recommendation letters, study plan, special achievements, professional skills (certificates or learning certifications), prize certifications, or language capability certification, etc.

※Mandarin Chinese is the main language of instruction at TPCU. Applicants should be proficient in Mandarin to be able to keep up with regular college course study officially. Applicants' language capability is reviewed by each department at the first review stage review. If necessary, each department can ask applicants to take the Test of Proficiency- Huayu (TOP).

※If the number of enrollees does not reach the enrollment quota, the school may decide whether to admit the student or not.

伍、修業年限 Program Duration

修業年限：碩士班2~4年；四年制學士班4~6年。

Years of Study: The master's program must be completed within two to four years, the four-year program must be completed within four to six years, and the five-year junior college program must be completed within five to seven years.

Applicants who are announced to register should follow the date mentioned in the letter of admission and be physically at school to run registration process. Passports, graduation documents, transcriptions (verified and sealed by Republic of China (Taiwan) embassies and consulates) and Health Certification (Including an HIV report) should be handed in. If applicants who are announced to register are late for registration, their application qualification will be cancelled.

- 一、同時申請一個以上系所者，僅能選擇其中一系所報到註冊。
1. Applicants who apply for more than one program can only register into one of them.
- 二、外國學生凡已在國內完成申請就學或遭退學者，不得再向本校申請入學。若違反此規定並經查證屬實者，撤銷其所獲准入學資格或開除學籍。
2. If an international student has already applied domestically or has dropped out from a school, he or she is not allowed to apply to TPCU. If an applicant violates the above regulations and has been verified to be true, his or her application qualification will be cancelled and expelled.
- 三、獲准入學之外國學生，到校時若已逾該學年第一學期三分之一時程者，於第二學期註冊入學。
3. Any admitted international student who arrives on campus after more than one-third of the first semester shall not be enrolled for the semester of that academic year.
